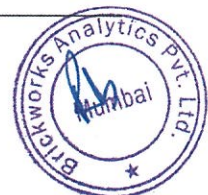

Overview

The summer placement process for the batch of 2022 of the Post Graduate Programme in Food and Agribusiness Management (PGP–FABM) at IIM Ahmedabad was successfully completed on December 04, 2020. All 47 students of the batch opted for placements through the Institute and were placed in less than a day, further corroborating the quality of students and the pertinence of this specialized program to the Food and Agribusiness sector. The batch explored opportunities in a diverse set of industries within the food, agri-business and allied sectors. A total of 39 companies participated in the placement process, ranging from sectors as FMCG, Agri Inputs and Services, Food Processing and Supply Chain, Food and Agribusiness PE-VC, Food and Agri Consulting, e-Commerce, and Retail.

The process welcomed first-time recruiters like FMC, Corteva Agri sciences, Emami Agro Tech, Agro Tech Foods, Modern Foods, Yes Bank, MicroSave Consulting, Nutreco, UPL, Eco Vision, Amplus Solar, East West Seeds, IFF and Everest Instruments. Nestle, UBL, Amway, Innothera (earlier known as Pioneering Ventures) renewed their relationship with the PGP-FABM programme. Other regular recruiters including Cloudbtail reaffirmed their confidence in the programme, extending multiple offers to the students. The students also embraced opportunities with start-ups in the agribusiness domain like Grow Indigo. The students attracted opportunities across multiple roles in Consulting, Sales & Marketing, Brand Management, Supply Chain, Operations, Engineering & Technology, Project Management. The process helped students choose sectors and roles that best fit their career aspirations.
