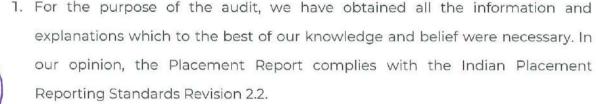

#### Overview

The summer placement process for thePGP-MBA Class of 2023 of the Post Graduate Programme (PGP) in Management at IIM Ahmedabad was successfully completed in November 2021 in an online mode. Firms from multiple domains participated virtually across the three clusters in Summer Placements, with all students being placed across more than 20 cohorts. The successful completion of the recruitment cycle for the batch stands testament to the high quality of students at the institute and the robust nature of the placement process that provides adequate flexibility to both students and recruiters.

#### **Placement Process**

132 firms participated with 219 different roles in the summer placement process in 2021. Firms were grouped into cohorts based on the industry and sector, and groups of cohorts were invited to campus across different clusters. As in previous years, students were provided the flexibility of making "dream" applications to firms of their choice in a subsequent cluster even with an offer in hand. Around 120 students made over 220 dream applications this year. This gave students the flexibility and choice to build careers in sectors of their preference.

#### Sectoral overview

Firms from different sectors participated in the process at IIM Ahmedabad. Recruiters in the management consulting domain included Alvarez & Marsal, Arthur D. Little, Synergy Consulting, Auctus Advisors, Bain & Company, Boston Consulting Group, GEP Consulting, Kearney, KPMG, McKinsey & Company, Pricewaterhouse Coopers and Strategy&.

Prominent recruiters in the Investment Banking and Markets space included Avendus Capital, Bank of America, Citibank, Credit Suisse (India), Edelweiss Wealth Management, Goldman Sachs, JP Morgan, HSBC, Morgan Stanley and Nomura (Singapore and India). In the Private Equity and Venture Capital domain, we saw participation of firms like Blackstone, Gaja Capital, I Squared Capital, MYRA SHS Renewables, The Xander Group, True North and White Oak Capital.



Consumer goods and durables, consumer services and consumer electronics cohorts saw participation by regular recruiters like AB InBev, Airtel, Asian Paints, Coca-Cola, Colgate, Dabur, HUL, ITC, Kimberly Clark, Lenovo, Mondelez, Nestle, P&G, Puma, Reckitt Benckiser, Samsung Electronics, Tata Sky and Wipro Consumer Care among others.

The conglomerates cohort saw participation from Adani, Aditya Birla Group, Bajaj Group, JSW, Mahindra Group, RPG Group and Tata Administrative Services, among others. Retail B2B & B2C cohort consisted of firms like Amazon, Udaan, eShakti, Flipkart, and Purplle. In the Pharma & Healthcare cohort, firms like Apicore, MedTel Healthcare, Optum United Healthcare, PhableCare, Stryker India and Dr. Reddy's participated. The Consumer Tech cohort comprised firms like Adobe, Atlassian Corporation, IkigaiLabs, Microsoft, Oracle and Sprinklr. The Renewable Energy and Green Tech cohort saw participation fromReNew Power.

Banking & Insurance sector saw participation from firms like ICICI Bank, Kotak Mahindra Bank and Axis Bank. Tata Consultancy Services and InfoEdge participated in the IT Consulting cohort and Vedanta and Ola Electric participated in the Core Manufacturing & Infrastructure cohort.

There were 53 new recruiters this year, including Electronic Arts, Himalaya, Iroha Investment Management, Landmark Group, Mondelez, PharmEasy, Jupiter Capital and Venture Highway.

#### **Top Recruiters**

In the Management Consulting cohort, Boston Consulting Group was the top recruiter with 25 offers, followed by Bain & Company with 20 offers. In the Advisory Consulting domain, PwC made the maximum offers - 10 and in the Niche Consulting sector, GEP and Synergy Consulting made the highest offers –3 each. Goldman Sachs was the highest recruiter in Investment Banking and Markets cohort with 9 offers and True North and Xander Group



was the highest recruiter in the PE/VC and Asset Management cohort with 3 offers each. In the Consumer Goods, Consumer Electronics and Consumer Services domain, HUL extended the most offers - 14, followed by Samsung Electronics with 9 offers and Airtel with 4 offers. With 7 offers, Tata Administrative Serviceswas the largest recruiter in the Conglomerates cohort. Amazon was the highest recruiter in the Retail B2B & B2C domain with 11 offers. In the IT Consulting cohort, Tata Consultancy Services was the largest recruiter with 11 offers. Ola Electric was the highest recruiter in the Core Manufacturing & Infrastructure cohort with 5 offers.
