#### Overview

The PGP-FABM (Post-Graduate Programme in Food & Agribusiness Management) summer placement process for the batch of 2021-23 was completed successfully on 19th November 2021. The process was carried out in an online mode. 47 students of FABM Class of 2021-23 will do a summer internship in the months of April-June 2022. The successful completion of the placement process within a day is a testament of the high-quality learning experience at the institute and the robust placement process that provides adequate flexibility to both recruiters and students.

The FABM students looking for summer placements were well received by the industry and 45 companies participated in the placement process. The placements witnessed a balance of roles from all the sectors like Agro-Chemicals, Commodities, Food Supply Chain, Food industry, Agri consulting, e-Commerce, FMCG Retail and other sectors.
